CI 130. 13. TO RECEIVE THE YNYSYMAENGWYN TRUST REPORT

13.12.23 The Chair of Ynysymaengwyn Trust, Cllr. Aled Lewis had given his apologies to the Meeting and provided the following written report.

Mark Blunden will be retiring from his role as Woodland Manager at Ynysymaengwyn at the end of December and Rob Blunden has been promoted to succeed Mark.

Following the closure of the caravan park at the end of the season, the playpark equipment has been removed, surrounding fence taken down, and the multiple layers of wood chip, some 350mm in depth, excavated down to the base layer in preparation for the erection of a new playpark incorporating inclusive elements. Erection of the new park will commence in the New Year with the aim for the work to be fully completed in readiness for Easter.

Fencing along the Afon Dysynni riverbank, the old boathouse section is imminent, these works will be undertaken by a local fencing contractor.

The latest tree inspection report from Arbtech has been received and any lopping, pollarding or, in some instances felling, will be undertaken in line with the suggested actions contained in the report.

Other works will continue in the woodlands over the closed season as in previous years, ie, footpath and bridge maintenance, replacement of signage and replanting of trees with various native hardwood species.

The next Ordinary meeting is scheduled for Wednesday 10th January 2024 at 7.00pm.
